ACKNOWLEDGEMENT OF GENERAL CONDITIONS OF STATE SUPERVISION

I understand that any STATE sentence imposed by the Court will be subject to certain general and/or specific conditions along with other general and specific conditions imposed by the Pennsylvania Parole Board. In addition to any conditions imposed by the Court on the record at the time of my hearing, I understand that the general conditions of state supervision set forth below will also become part of and be incorporated into any such sentence(s). I have read these conditions carefully and have reviewed them with your lawyer, if applicable. By placing my initials next to each such condition, I acknowledge that I have read and understand each such condition.

- _____ 1. I will report in person or in writing within 24 hours to the district office or sub-office listed below, and will not leave that district without prior written permission of the parole supervision staff.
- _____ 2. My approved residence upon being paroled may not be changed without the written permission of the parole supervision staff.
- _____ 3. I will maintain regular contact with the parole supervision staff by:
- a. reporting regularly as instructed and following any written instructions of the Board or the parole supervision staff.
 - b. notifying the parole supervision staff within 72 hours of: (1) my arrest; or (2) my receipt of a summons or citation for an offense punishable by imprisonment upon conviction; and
 - c. notifying the parole supervision staff within 72 hours of any change in status, including, but not limited to, employment, on-the-job training, and education.
- _____ 4. I will comply with all municipal, county, state and Federal criminal laws, as well as the provisions of the Vehicle Code (75 Pa.C.S. § 101 et seq.), and the Liquor Code (47 P.S. § 1-101 et seq.)
- _____ 5. I will:
- a. abstain from the unlawful possession or sale of narcotics and dangerous drugs and abstain from the use of controlled substances within the meaning of the Controlled Substance, Drug, Device, and Cosmetic Act (35 P.S. § 780-101 et seq.) without a valid prescription;
 - b. refrain from owning or possessing any firearms or other weapons; and
 - c. refrain from any assaultive behavior.
- _____ 6. I shall pay fines, costs, and restitution imposed on me by the sentencing court. I shall establish with appropriate county authorities within 30 days of my release from prison a payment schedule for the fines, costs and restitution owed for those cases for which I am now on state parole. Thereafter, I shall:
- a. pay these obligations according to the established payment schedule or as ordered by the court;
 - b. provide proof of such payment to parole supervision staff; and
 - c. keep the parole supervision staff and the court informed of any changes in my financial ability to pay fines, costs and restitution.

____ 7. I shall comply with the any other special conditions imposed by the Board along with special conditions imposed by the parole supervision staff and the sentencing court.

____ 8. I shall also comply with all other special conditions imposed by the Court at the time of my sentencing.
